I. Welcome and Introductions/Roll Call

II. Raise Performance – Focus Area and Open Discussion

- a. **June Spotlight:** The Anchor Teams provided a review of the plan feedback documents sent to regions by HHSC including what the different feedback comments are and guidance on how providers should review and address HHSC's requested changes.

- All Providers should review and confirm:

 - Provider Information
 - IGT Funding

- b. **Open Discussion:** Participants had an opportunity to pose questions to peers and the Anchor Teams, as well as provide feedback related to plan feedback comments from HHSC, how to respond, assistance in addressing updates, etc.
- **Question:** We had a request from higher management to add additional contacts, are we still only able to have three contacts?
 - **Answer:** You can only have three lead contacts, but you can have additional contacts with HHSC. HHSC may want to limit the contacts on the plan to three though. We can add a comment to ask HHSC about that.
 - Brief discussion over early baseline reporting slated to start July 2, 2018.
